Off-Agenda Report on Psychiatry Recruitment

This memo comes as an update on progress since the last off agenda update on May 4; and for reference to Item #56 on the June 20, 2017 Board of Supervisors Agenda, which asks for approval of \$6M of various agreements for Locum Tenens Psychiatry Services for the Behavioral Health Services Department.

Summary:

After the successful negotiation of the UAPD contract which was ratified by the Board of Supervisors in October 2016, SCVHHS has successfully hired nine (9) psychiatrists into coded positions by June 9, 2017.

BAP: 1 position (1 FTE) – Dr. Rashi Agarwal

VMC Ambulatory Clinics: 1 position (1 FTE) – Dr. Beeta Verma Custody: 2 positions (1.5 FTE) – Drs. Anh Tran, Ariel Troncoso

In addition, there are nine other psychiatrists in the pipeline that are going through credentialing to be hired in the next six months by December 30, 2017.
