Subject: <u>Status Report as of October 1, 2016</u>

<u>Finance and Government Operations Committee (FGOC) Special Hearings on Recommendations to Improve the County's Custody Operations and Facilities</u>

This report provides a brief summary of the status of recommendations received by the Board of Supervisors to improve the County's custody operations and facilities. As of October 1, 2016, the Board had received a total of 655 recommendations from 15 sources. Review and analysis of these recommendations by the Finance and Government Operations Committee through special hearings commenced on August 26, 2016 when the Committee reviewed 105 recommendations.

During the most recent special hearing held on September 30, 2016, the Committee reviewed a total of 81 additional recommendations which pertained to External Oversight, Reporting, and Organizational Accountability (46), Americans with Disabilities Act (ADA) Facilities and Programs (14), and an assortment of other recommendations (21) that were determined by the County Executive and County Counsel to either not be recommendations, or to be illegal under current law. These 21 recommendations, which included two of the 46 External Oversight Reporting and Organizational Accountability recommendations discussed at the September 30, 2016 special hearing, and two of the 36 Inmate Classification Policies and Procedures recommendations discussed at the August 26, 2016 special hearing, were removed from consideration by the Committee.

Therefore, as of October 1, 2016 the Committee has reviewed an unduplicated total of 182 recommendations, or 27.8 percent of the 655 recommendations received by the Board of Supervisors.

No formal requests for additional information were made in relation to any specific recommendations at the

September 30, 2016 Special Hearing. Formal action was taken by the Committee at the September 30, 2016 Special Hearing by removing from consideration a total of 21 recommendations as previously described. Lastly, 27 additional recommendations were referred to staff for legal analysis or rewording to correctly identify the responsible County department referenced in the recommendations prior to review by the Committee.

Attached to this memorandum are two graphs illustrating the total of 655 recommendations (in blue) by SOURCE and by CATEGORY, and the 182 recommendations that were reviewed by the Committee (in pink) since the August 26, 2016 Special Hearing. Also attached is a numerical matrix, which reports the same information in chart format. Specific information identifying individual recommendations that were reviewed during the September 30, 2016 Special Hearing is available at the County website at the following address www.sccgov.org/jailreforms

<sup>1</sup> Of the 21 recommendations determined by the County Executive and County Counsel to either not be recommendations or to be illegal under current law, two were included in the 105 recommendations reviewed by the Committee on August 26, 2016, and two were included in the 60 recommendations discussed at the September 30, 2016 special hearing. Consequently, 17 recommendations were removed by the Committee at the September 30, 2016 special hearing based on the recommendation of the County Executive and County Counsel, since they had been determined to not be recommendations or legal under current law. Therefore the total number of recommendations considered by the Committee through its September 30, 2016 meeting amounts to 182 (105+60+17).



## FGOC STATUS REPORT REVIEW OF 655 CUSTODY RECOMMENDATIONS BY


